WV Code §59-1-2a requires organizations registered through the West Virginia Secretary of State to file an annual report, and pay the annual report \$25.00 filing fee between January 1 and July 1 of each year following the calendar year in which the business was registered with the Office of the Secretary of State.

The report and \$25 filing fee must be filed and paid between January 1 and July 1 of each year following the calendar year in which the business was registered. See West Virginia Code 59-1-a.
