Step 1. Validate the Debt. The Fair Debt Collection Practices Act gives you the right to ask a debt collector to verify the debt really is yours.. You can write the debt collector a debt validation letter asking for proof you owe the money. In your letter, ask the collections agency to remove the collection if they can't prove you owe the money.. You'll need to request validation within 30 ...
